Die ehemaligen Quellriede am Rande des Biotops haben sich aufgrund der Entwässerung des gesamten Quellmoorkomplexes in eine Brennessel-Sumpfschilf-Hochstaudenflur auf feuchten bis sehr feuchten, mäßig degradierten Torfen umgewandelt.
