Dieser ist jedoch weder zu Fuß noch mit dem Boot erreichbar, da er von dichten, hoch überfluteten Schilf- und Schneidenröhrichten umgeben ist. Zu erkennen war von Ferne ein junger Birkenaufwuchs. Das Luftbild lässt neben Schwingtorfdecken mit Moorbirkenaufwuchs zudem ein Schilfröhricht ggf. mit flutenden Torfmoosen vermuten.
